

Florida Department of Children and Families Identifying and Reporting Child Abuse and Neglect Training

As part of the requirement for youth camps and programs that are held on University of Miami campuses, all directors, staff, and volunteers (which includes University staff and faculty members) who work with minors are required to complete the Florida Department of Children and Families (DCF) online training module - Identifying and Reporting Child Abuse and Neglect. This comprehensive training consists of the following topics related to minors:

Module 1

Identifying Child Abuse and Neglect

- Overview
- Course Introduction

Module 2

Reporting Child Abuse and Neglect

- Course Conclusion
- Resources
- Course Links and Documentation

The training is free to anyone who registers through the DCF portal. Although the training refers to responsibilities involving teachers and others, the same information also applies to anyone who works with minors in youth camps and programs.

The training takes approximately one hour to complete and contains a quiz that must be passed in order to successfully complete the training. You have the option to read the passages contained in the training module, or you have the option to place the training in "Listen" mode. This will allow you to hear the passages as you go through the training.

Once an individual has undergone the training modules and successfully passed the quiz, they will be given the option to download a certificate of completion at the end of the course. Once the certificate has been downloaded, a copy must be sent to Conference Services c/o Jon Baldessari at jon.baldessari@miami.edu.

To report incidents of Child Maltreatment to the Title IX Coordinator:

1. Go to www.miami.edu/youthprograms
2. Scroll down to Title IX section
3. Select Youth Programs and Activities on the left
4. Select "Report Child Maltreatment"
5. Either upload a copy of the completed DCF Fax Reporting Form or complete and submit the University Online Reporting Form. (You will receive a copy of your report via email, which you may then submit to DCF via fax.)
